**ORDER
(FEE APPROVAL)**

THIS MOTION, made by the Plaintiff and Siskinds LLP (“**Siskinds**”) for an Order: (i) approving the retainer agreement between the Plaintiff and Siskinds dated August 4, 2010; (ii) approving Class Counsel Fees; and (iii) approving the payment of an honorarium to the Plaintiff, was heard this day at 85 Frederick Street, Kitchener, ON N2H 0A7, by video conference.

ON READING the materials filed and on hearing the submissions of Siskinds;

AND ON BEING ADVISED that the Defendants take no position with respect to this motion:

1. **THIS COURT ORDERS** that, except as otherwise stated, this Order incorporates and adopts the definitions set out in the Settlement Agreement reached between the Plaintiff and the Defendants on July 8, 2020.



2. **THIS COURT ORDERS** that the retainer agreement between the Plaintiff and Siskinds dated August 4, 2010 is hereby approved.

3. **THIS COURT ORDERS** that Class Counsel Fees in the all-inclusive amount of CAD\$5,993,755.05 are hereby approved and payable from the Settlement Funds to Siskinds on or after the Effective Date, comprising:

- (a) CAD\$4,337,323.55 for legal fees;
- (b) CAD\$563,852.06 for taxes on legal fees;
- (c) CAD\$966,884.46 for disbursements, including a disbursement of CAD\$100,000.00 payable to Augusta Ventures Canada Ltd.; and
- (d) CAD\$125,694.98 for taxes on disbursements.

4. **THIS COURT ORDERS** that Siskinds shall pay the amount of CAD\$2,210,332.47 from Class Counsel Fees to Robins Geller Rudman & Dowd LLP and Hagens Berman Sobol Shapiro LLP on or after the Effective Date.

5. **THIS COURT ORDERS** that an honorarium of \$29,500.00 to the Plaintiff, Tajdin Abdulla, is hereby approved and payable from the Settlement Funds to the Plaintiff on or after the Effective Date.
